WHEREAS admissions on Local transfers is completed and 18.07.2023 is scheduled to be closing day for admitting the students

WHEREAS consequent upon local transfers / admission on transfers from one station to another station, the class / section average strength would have come down to less than the Kendriya Vidyalaya Sangathan's prescribed strength (40)

WHEREAS, prior to closure of fresh admissions against vacancies as on 30th June 2023, the Kendriya Vidyalayas must have had some registrations against each class as **waitlist duly approved by Chairman VMC** which perhaps already displayed in the notice board.

WHEREAS, if waitlist **duly approved by Chairman VMC** of the kind described above is available with the Kendriya Vidyalaya, then the Principals are directed to get ready to operate "**Waitlist**" **purely in terms of above description**.

It is now therefore, the undersigned exercising his powers vested under Rule 11 of Part A of Kendriya Vidyalaya Sangathan Admission guidelines for 2023-24, directs the Principals to operate "**Waitlist**" **as detailed above and go for admission against vacancies arised out of ibid local transfers and complete the admissions by 30.07.2023**.

Please note that, **No Fresh Registrations for any class should be done now** at Vidyalaya level with or without Chairman VMC **to create Waitlist** under any circumstances. Only "Waitlists" available and approved by Chairman VMC prior to **30th June 2023** should be used a valid Waitlist.
